1 Introduction

These Release Notes relate to TMF Reference Model v3.3.1, the first maintenance update to TMF Reference Model v3.3, which was released in March 2023.

A maintenance update is defined as modifications made to the Reference Model that have no significant impact on adoption or implementation of the Model.

Examples of changes that would require a maintenance release include:

- Changes to the definition/purpose text that do not substantially modify the meaning, e.g., additional text for clarification
- Inclusion or deletion of example sub-artifacts
- Addition or modification of regulatory guidance references
- Correction of typographical errors
