



Real World Studies TMF Reference Model

Now finalized and submitted to the SC for review and approval.

Real World Studies are defined as "Human Research Studies whose design does not follow a traditional clinical trial framework" and may also be known as:

- Non-interventional studies
- Disease registry studies
- Natural history studies
- Post-market clinical follow up studies (medical device)
- Observational studies
- Non-IND studies

Based on the standard TMF Reference Model v3.1, the RWS Model comprises

- 11 Core artefacts
- ▶ 119 Recommended artefacts

Some zone, section, and artefact name changes to reflect RWS terminology


UK withdrawal from the EU on 31 January 2020 share

Press release 31/01/2020

The withdrawal agreement foresees that following its departure from the EU on 31 January 2020, the UK will no longer participate in EU institutions and their decision—making. For EMA this means that as of 1 February 2020, no one who represents the UK, or is appointed or nominated by the UK can participate in meetings of EMA's scientific committees, working parties or the Agency's Management Board.







